

RECORDED. OUT THIS WAY IN LIVINGSTON COUNTY IF THE COPS DO NOT SIGN FOR IT THEN IT NEVER EXITED. WE WOULD NEVER SEE ANY OF THOSE GUNS AGAIN. THEY WERE TAKING MY GUN AND MY TWO BROTHERS GUNS. MY OLDER BROTHER TRIED TO TELL THEM THAT THEY WERE TAKING HIS PROPERTY BUT THEY CAME BACK WITH A WISE ASS QUESTION OF DO YOU HAVE A SALES RECEIPT TO PROVE IT. THEY TOOK EVERY THING. THERE WAS A GUN BOLT THAT WAS SITTING ON THE COUNTER. SOME ONE OF THOSE COPS POCKETED IT AND DID NOT LIST IT ON THE INVENTORY. IT WAS NEVER RETURNED, NEITHER WAS AN EXPENSIVE MILITARY BIPOD AND NEW COMPLETE CLEANING KITS THAT WERE IF THE STOCK OF SOME OF THE GUNS. THEY TEST FIRED ALL OF THESE GUNS AND USED THE WRONG BULLETS IN SOME. THEY FIRED BRAND NEW GUNS THAT WERE STILL IN THE FACTORY GREASE, DEVALUING THEM. THEY SHOT ANTIQUES THAT WE NEVER FIRED. I WAS FORCED TO LEAVE LONG BEFORE THESE COPS LEFT BUT MY BROTHER LATER TOLD ME THAT THEY WERE CARRYING THESE GUN OUT IN THEIR ARMS LIKE A PILE OF CORD WOOD AND DUMPING THEM INTO THE TRUNK OF THEIR CARS WITHOUT ANY PROTECTION ON THEM. THEY HAD NO RESPECT FOR OUR PROPERTY. SOMETHING WE CHERISHED AND TREATED WITH CARE THEY VIOLATED LIKE IT WAS TRASH. NO ONE IS REIMBURSING US FOR ANY DAMAGE OR PROPERTY LOSE. THEY KEPT THESE GUNS FROM ALL OF US FOR WELL OVER A YEAR. I BELIEVE THAT THEY DID MORE THAN JUST TEST FIRE THEM. I THINK THE COPS OF CALEDONIA WERE USING THEM LIKE THEIR OWN PERSONAL PROPERTY. I OF COURSE STILL CAN NOT HAVE THE USE OF ANY OF MY GUNS BECAUSE OF THIS ORDER OF PROTECTION THAT IS STILL IN EFFECT. EVEN IF THE MINOR CHARGES DO NOT WARRANT MY NOT HAVING FIREARMS, THEY ARE USING THIS ORDER OF PROTECTION TO KEEP ME FROM EVER HAVING THE RIGHT TO USE A GUN AGAIN FOR ANY REASON, LIKE HUNTING.

THE POLICE HAD NO RIGHT TO GO TO WHAT WAS THEN MY HOUSE AND TAKE GUNS THAT WERE NOT USED IN THIS INCIDENT AT THE BANK AND HAVE THEM TEST FIRED.

SINCE THEY ARE LIBELING ME, I WOULD LIKE SOMETHING MORE LIKE THE VIDEO OF ME REACHING ACROSS THE COUNTER AT THEIR BREAST AND THE BLOUSE.

2) ANGELA KENNEDY, WHO SAYS SHE ALSO WAS WEARING THIS SAME KIND OF BLOUSE STATES THAT A FEW WEEKS BEFORE I ASKED HER IF I COULD PET THE KITTY WHILE I HELD MY RIGHT HAND UP. SHE REPORTED THIS TO THE MANAGER WHO SAID SHE WOULD SPEAK TO ME THE NEXT TIME I CAME IN. THIS HAPPENED WITH TWO PEOPLE ON SEPARATE OCCASIONS, BY THE DATES OF MY BANK VISITS ABOVE, THAT MEANS THE MANAGER WAITED OVER FOUR MONTHS, TO ADDRESS THIS SITUATION WITH ME, WITHOUT GOING OUTSIDE THAT BANK BRANCH FOR ADVISE OR HELP.

3) TAMMIE WHITEMAN STATES IN HER DEPOSITION THAT HER HEARSAY COMMENT ABOUT ME WAS THAT I NOT ONLY ASK TO PET KITTY BUT REACHED OUT TOWARDS THE GIRL. THIS WOULD PUT MY HAND OVER THE COUNTER TO TRY AND TOUCH HER. WHERE IS THE BANK VIDEO OF THIS BEHAVIOR.

4) MEGAN DAILEY STATED THAT I MADE INAPPROPRIATE COMMENTS TO A CO-WORKER AND SHE IS TELLING PEOPLE THIS UNPROVEN SLANDER ABOUT ME.

5) IN SIMMS DEPOSITION HE QUOTES ANGELA AS TELLING HIM, WHILE
