INTENSE ABOUT IT. IN JUST READING THESE DEPOSITIONS WITH ALL
THE INACCURATE COMMENTS OF WHAT HAPPENED AND INTENSE SWEARING
AND YELLING THAT IS BEING MENTIONED, I AM GETTING A HEADACHE

MY COMMENTS TO BARBERS STATEMENT IS THAT I NEVER HAD ANY
TROUBLE IN THE BANK WITH THESE GIRLS NOR DID I EVER TRY TO
MOLEST ANY OF THEM. BABBER STATES THAT ALL THESE GIRLS ARE
COMPLAINING ABOUT COMMENTS AND BEHAVIOR YET DID NOT OFFER
ANY PROOF TO BACK UP WHAT THEIR ACCUSING ME OF. INSTEAD OF
JUST WAITING AND AMBUSHING ME, I WISH THAT BARBER HAD FOUND
SOME OTHER WAY OF BRING THIS TO MY ATTENTION. BARBERS METHOD
OF GETTING DOWN TO THE BOTTOM OF THIS IS TO STATE TO MY
FACE THAT THIS ACTUALLY HAPPENED AS IF IT WAS TRUE. SHE DID

NOT ASK ME IF THIS WAS TRUE. SHE STATED THAT I WAS MAKING LEWD COMMENTS. WITH OUT ANY PROOF OR ASKING ME MY SIDE OF THIS. SHE BY THAT STATEMENT IS ACCUSING ME OF BEHAVING LIKE A SEXUAL PERVERT. BARBER JUST QUIETLY AND RUDELY SAT THEIR IGNORING ME WITH HER ELBOWS ON THE DESK AND HER FINGERS TO HER MOUTH LOOKING OUT THE EAST WINDOW. SO WITH OUT BEING TOLD I STARTED TO LEAVE THE BANK. ONLY THE PEOPLE OUT OF THAT OFFICE ARE ALLEGING THAT I WAS SWEARING AND MAKING STATEMENTS CONTAINING FOWL INTENTIONS. SIMM NEVER ASKED ME TO LEAVE THE BANK HE JUST THREW HIS ARMS AROUND MY NECK AND MANUALLY TRIED TO THROW ME OUT OF IT BUT HE JUST WAS NOT MAN ENOUGH. STILL, BARBER NEVER SAID ANYTHING TO SIMM TO STOP HIS BEHAVIOR, AT ANY TIME, NOT THE ATTACKING OR HIS MENACING ME. NO ONE SAID THAT THEY HEARD HER ATTEMPT TO STOP SIMM. THE GUN DID COME OUT BUT SIMM WAS THE ONE WHO REMOVED IT. AGAIN BARBER COULD NOT SEE THIS. UNFORTUNATELY, FOR ME THE VIDEO EVIDENCE OF THIS WAS EDITED OUT AND WITHHELD.
